I have distributed Applications to all high schools within our outlined district including Tulare County high schools. Ap-

The qualifications for applicants are as follows:

1. Students must be of Portuguese descent on father's or mother's side, be a USA citizen or permanent resident.
2. Maintained a minimum of 3.50 grade point average in high school (Grades 9-12) and be a graduating senior of a California high school. **Transcript of grade records must accompany application.**
3. Meet all requirements set down by an

accredited university or college of the student's choice.

4. Participated in at least **three** extra-curricular activities while in high school.

Applications are due: **March 15, 2012, they must be post marked by this date.**
